

AN ORDINANCE AMENDING ORDINANCE NO. 4788, THE MUNICIPAL CODE OF THE CITY OF RICHMOND HEIGHTS, MISSOURI, SECTION 500.050, BY ADOPTING THE INTERNATIONAL MECHANICAL CODE OF ST. LOUIS COUNTY, MISSOURI, ORDINANCE NO. 24,438, AS THE MECHANICAL CODE OF THE CITY OF RICHMOND HEIGHTS, MISSOURI.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF RICHMOND HEIGHTS, MISSOURI, as follows:

SECTION 1. The St. Louis County Mechanical Code, being the International Mechanical Code/2009 published by the International code council, adopted by St. Louis County on July 14, 2010, by Ordinance 24,438 attached hereto as Exhibit "A", and incorporated herein by reference, one copy of which is on file with the Office of the City Clerk for a period of fifteen days prior to passage of the Ordinance, is hereby adopted as the Mechanical Code of the City of Richmond Heights, Missouri.

SECTION 2. Section 500.050 of Ordinance No. 4788, Municipal Code of the City of Richmond Heights, Missouri, is hereby repealed and deleted in its entirety and a new Section 500.050 is enacted in lieu thereof to read as follows.

SECTION 500.050 International Mechanical Code adopted

The St. Louis County International Mechanical Code/2009 adopted by St. Louis County Ordinance 22,313 on July 14, 2010, being the international Mechanical Code/2009, approved and adopted by the International Code Council, is hereby adopted and by reference made a part of this Chapter as though set out in full herein.

SECTION 3. If any section, subsection, provision, sentence, clause or phrase of this Ordinance or of the International Mechanical Code/2009 is, or any reason held to be unconstitutional or invalid, such decision shall not affect the validity of the remaining portions of this Ordinance or of said Codes, and the City Council hereby declares that it would have passed the same even though such portion so held to be unconstitutional had not been included therein, and to this end the provisions of this Ordinance are declared to be severable.

SECTION 4. Penalties for violations of this ordinance shall be as provided in Section 100.150 of the Municipal Code of the City of Richmond Heights.

SECTION 5. This Ordinance shall take effect and be in full force on the thirty-first day following its passage as provided by law.
