Photo I.D./Membership Information

Resident Photo I.D. Card

All City of Maplewood and Richmond Heights' residents, who do not have a membership to the Maplewood Family Aquatic Center or THE HEIGHTS, must purchase a Resident I.D. Card for \$5. This card guarantees the resident will receive the resident rates on all daily fees for recreation programs. The initial cost includes the card and one daily visit. Without this Resident I.D. Card there will be no entry to the facility. There is no replacement for lost or stolen cards, a new card must be purchased. The Resident I.D. Card must be renewed each year at a cost of \$5.

Membership Photo I.D. Card

All guests purchasing a membership to the either facility will receive a photo I.D. Card. The rules and guidelines for this card include:

1. Cards and memberships are valid thru the pool season.
2. **No refunds are given for memberships unless proof of relocation is presented. A \$20 cancellation fee will be charged at the time of cancellation.**
3. Proof of residency must be displayed to purchase resident I.D. Cards or memberships. Proof of residency must be displayed each year at renewal.
4. To receive resident rates for programs or facility rentals, participant or renter must display a resident I.D. Card or resident membership card.
5. Members and cardholders must abide by rules and regulations of the Cities of Maplewood and Richmond Heights or privileges may be revoked.
6. Memberships are non transferable.
7. Children ages 2 and under are not required to have a card or present a card when accompanied by an adult member.
8. Cards may be purchased the first two weeks at the guest services desk at the Maplewood Family Aquatic Center and anytime at THE HEIGHTS during operating hours.
9. There is no replacement fee for lost or stolen cards, a new card must be purchased.
10. A parent or guardian must accompany youth, ages 15 and younger, when purchasing a membership I.D. Card.
11. No refunds are given for I.D. Cards or membership cards.

Youth Participants

Children 9 years and younger require supervision. These children must be supervised by those 15 years of age or older wearing a swimsuit.

Waiver and Release of Liability
