## Photo I.D./Membership Information

### Resident Photo I.D. Card

All Maplewood, Richmond Heights, Brentwood and Rock Hill City residents, who do not have a membership to the Maplewood Family Aquatic Center or THE HEIGHTS, must purchase a Resident I.D. Card for \$5. The I.D can only be purchased at THE HEIGHTS. This card guarantees the resident will receive the resident rates on all daily fees for recreation programs. The initial cost includes the card and one daily visit. Without this Resident I.D. Card there will be no entry to the facility. There is no replacement for lost or stolen cards; a new card must be purchased. The Resident I.D. Card must be renewed annually at a cost of \$5.

### Membership

The rules and guidelines for MFAC memberships include:

1. MFAC memberships are only valid thru the outdoor pool season.
2. **No refunds are given for memberships unless the resident is moving and can show proof of relocation. A \$20 cancellation fee will be charged at the time of cancellation.**
3. **No refunds are given for membership key FOBs or resident I.D. Cards.**
4. All guests purchasing a membership to MFAC will receive a key FOB. The key FOB must be presented at each visit.
5. Proof of residency must be displayed to purchase resident I.D. Cards or memberships annually.
6. Members and cardholders must abide by facility rules or privileges may be revoked.
7. Memberships are non transferable.
8. Children ages 2 and under are not required to have a membership or present a card when accompanied by an adult member.
9. Resident ID Cards may be purchased at THE HEIGHTS anytime during operating hours.
10. There is a \$5 replacement fee for lost or stolen cards or key FOBs; a new card must be purchased.
11. A parent or guardian must accompany youth, ages 15 and younger, when purchasing a membership.

### Youth Participants

Children 9 years and younger require supervision. These children must be supervised by those 15 years of age or older wearing a lined swimsuit.

### Waiver and Release of Liability
