Local visitors from surrounding communities of the Mid-County area: Richmond Heights, Maplewood, Brentwood, Clayton, Ladue, Frontenac, University City, Shrewsbury, Olivette and Webster are expected to attend this one-day event. Lindbergh Park can accommodate 35 artist selling their work, as well as music, hands-on art activities for children, a children's art booth from Maplewood Richmond Heights Schools, selling of drinks and food are being planned for this event.

No charge for admission. This is a rain or shine event.

ELIGIBILITY

Open to all artists 18 years of age and older who exhibit work of original concept, design and execution. Participants are limited to 35.

RULES

1. All work must be hand-made originals in all media. WORK DONE BY A PRODUCTION STUDIO IS NOT ACCEPTABLE. No work will be exhibited which has been made with the use of commercial kits, molds, patterns, plans, stencils, or prefabricated forms. 2. Only ORIGINAL PRINTS will be permitted and they must be properly signed and numbered -photographers must print their own photographs, or be involved in and supervise the printing process. 3. The jury committee reserves the right to refuse exhibition of work that is not consistent with submitted images and the rules listed above. 4. Exhibitors may not bring pets or sound equipment to

the show area, the City of Richmond Heights reserves the right to enforce these restrictions at the time of the Fair and will require removal of any work in violation of the policy. The booth rental fee will not be returned if this is deemed necessary.

DISPLAY All exhibit spaces measure 10 ft. by 10 ft. Double booths are available.

OPEN SPACES - Artists provide their own canopy. All spaces are on grass. Artists must provide all display materials, backdrops, scaffolding (tables and chairs). There are a limited amount of 8' tables and 2 chairs (per booth) available for an additional fee. **ARTIST PARKING** Artist parking area adjacent to the park entrance, within walking distance. No shuttle required. **SALES** All proceeds go to the artist. Artists are responsible for collecting and filing Missouri sales tax. Tax information will be provided to all artists in their arrival packets. Respected fine art and craft professionals who are members of the Richmond Heights Art Committee jury artists.

MEDIA 20-30 juried local artists will exhibit work for sale in 10 categories. Ceramics, fiber/textiles glass, jewelry, mixed media 2D painting, photography, digital printmaking, drawing sculpture, wood

JURY PROCESS All applicants are juried anonymously. Each applicant's images are viewed individually.

Each artist may submit up to 5 entries – there is a 3 piece minimum.

Submissions should be 150 dpi jpeg images, proportions maximum 5" x 7".

Label as follows: Lastname_Firstname_1.jpg, Lastname_Firstname_2.jpg, and so on.

Scoring is based on originality, creativity, design, technique, craftsmanship and presentation. Decisions of the jury panel are final.

Applications will be accepted beginning January 15, 2017

Application Deadline is February 20 , 2017

Jury results will be announced March 5, 2017

Deadline to accept invitation, March 15, 2013 (booth fee payment required)
