Photo I.D./Membership Information

Resident Photo I.D. Card

All City of Richmond Heights' residents, who do not have a membership to the community center, must purchase a Resident I.D. Card for \$5. This card guarantees the resident will receive the resident rates on all daily fees at the center and for recreation programs. The initial cost includes the card and one daily visit. Without this Resident I.D. Card, nonresident rates will be assessed. You must purchase a new card if your card is lost or stolen. The Resident I.D. Card must be renewed each year at a cost of \$5.

Membership Photo I.D. Card

All guests purchasing a membership to the center will receive a photo I.D. Card. The rules and guidelines for this card include:

1. Cards and memberships are valid for one year from the date of purchase.
2. **No refunds are given for memberships unless proof of relocation is presented. A \$20 cancellation fee will be charged at the time of cancellation.**
3. Proof of residency must be displayed to purchase resident I.D. Cards or memberships. Proof of residency must be displayed each year at renewal.
4. To receive resident rates for programs or facility rentals, participant or renter must display a resident I.D. Card or membership card.
5. Members and cardholders must abide by rules and regulations of the City of Richmond Heights or privileges may be revoked.
6. Children ages 2 and under are not required to have a card or present a card when accompanied by an adult member.
7. Cards may be purchased at the guest services desk during operating hours.
8. There is a \$5.00 replacement fee for lost or stolen cards, a new card must be purchased.
9. A parent or guardian must accompany youth, ages 15 and younger, when purchasing a membership I.D. Card.
10. No refunds are given for I.D. Cards or membership cards.

Youth Participants

Children 9 years and younger require supervision. These children must either be supervised by an adult, play in the supervised "For Kids Only" area (limit of 2 hours and fee charged), or they can participate with a youth who is 15 years or older. Each youth, 15 and older, may supervise only one guest, 9 and younger.

Waiver and Release of Liability

The Richmond Heights Center is not responsible for any injury or loss of property suffered while participating in center activities, using center equipment, or on center premises, for any reason whatsoever, including ordinary negligence on the part of the center, its commission, employees, instructors, or agents. In consideration of my family's and my ability to use the center for fitness activities, I hereby release and covenant not to sue the center, its commission, employees, instructors or agents from any and all present and future claims resulting from my participation in center activities both present and future, that may be made by me, my family, estate, heirs, or assigns. I represent that I am in good health. I am aware that health and fitness activities may range from vigorous cardiovascular activity to the exertion of strength training and that these, and other activities at the center involve certain risks, including but not limited to death, disability, serious neck, and spinal injuries resulting in complete paralysis, heart attacks, and injury to bones, joints or muscles. My family and I are voluntarily participating in center activities with full knowledge of the inherent risks of property damage, personal injury and or death. I understand that the center encourages me to consult a physician before beginning any exercise program. I understand this waiver to be as broad and inclusive as the laws of the state of Missouri will permit and affirm that I am of legal age to and freely signing this waiver. I have read this waiver and fully understand the terms of this waiver. I agree to comply with the rules and regulations of The Heights Community Complex.
